### Data collected when browsing We Unite Website

Your interactions with We Unite Website may lead you to provide us with different type of personal information depending upon your access and use to our Website. Any such information is provided at your own choice and shall affirmatively and deliberately be released by you in accordance with the terms of this Privacy Policy.

### Browsing

You can access our Website home page and browse our site without having to register in any way. When you merely browse our Website, we do not collect any personal identifiable information. In the



absence of any registration on We Unite Website, we only collect basic anonymized information about your computer and connection, including the type of Internet browser you use, time spent on We Unite Website, the pages visited and the IP address of your internet service provider (ISP).

We will only use the information described above to monitor and improve our Website, ensure that we provide you with the proper information, and for security purposes.

## Data collected when corresponding with us

Although the We Unite logo and references to We Unite may appear on some third-party websites, please be aware that We Unite is not responsible for the privacy practices of other sites. This privacy statement applies solely to information collected by our Website. We encourage you to be aware when you leave our Website and read the privacy statements of each and every website that collects personally identifiable information.

## **Data Security**

We Unite takes every precaution to protect your information. When you submit personal information via We Unite Website, your information is protected both online and offline. For example, when our registration form asks you to enter personal information, the information is protected during transmission by an industry standard high level of encryption - 256-bit SSL.



Any information you provide us is stored on Servers hosted in Germany at the We Unite premises, which are controlled by We Unite in a secure environment, in a locked facility so as to safeguard your information and avoid any data loss to the extent possible, or in the European Economic Area (EEA) zone in accordance with applicable laws and regulations.
